This notice may be supplemented with any new, significant facts learned subsequent to its submission. By providing this notice, The Trustees of the Walters Art Gallery, Inc. dba the Walters Art Museum (“WAM”) does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

Nature of the Data Event

On November 18, 2023, WAM observed suspicious activity that disrupted the operability of certain computer systems and servers within its network. WAM initiated an investigation to understand the nature and scope of this event and determined that an unauthorized actor accessed certain files within its network between October 10, 2023 and November 18, 2023.

WAM, along with the support of third-party specialists, conducted a thorough and in-depth review of the files to identify individuals whose personal information was potentially impacted. This extensive process was completed on August 28, 2024. WAM thereafter worked to notify potentially impacted individuals.

The information that may have been subject to unauthorized access includes name, Social Security number, driver’s license and/or state identification, account number, account type, routing number, and institution name.

Notice to Maine Residents

On or about September 27, 2024, WAM began providing written notice of this event to ten (10) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

Other Steps Taken and To Be Taken

Upon becoming aware of this event, WAM investigated and responded to it, assessed the security of its network, and notified potentially affected individuals. As part of its ongoing commitment to the privacy and security of information in its care, WAM regularly reviews and enhances its existing policies and procedures related to data privacy to reduce the likelihood of a similar event reoccurring in the future. Further, WAM notified federal law enforcement regarding the event. WAM is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this event, at no cost to these individuals.

Additionally, WAM is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company and/or bank. WAM is providing individuals with information on how to place fraud alerts and credit freezes on their credit files, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade

Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

WAM is providing written notice of this incident to event state regulators, as necessary, and to the three (3) major credit reporting agencies, Equifax, Experian, and TransUnion.

The Trustees of the Walters Art Gallery, Inc. dba the Walters Art Museum (“WAM”) writes to inform you of an event that may impact the security of some of your information. We have received no indication of any actual or attempted identity theft or fraud as a result. However, this notice provides information about this event, our response, and resources available to you to help protect your information, should you feel it necessary to do so.

What Happened. On November 18, 2023, WAM observed suspicious activity that disrupted the operability of certain computer systems and servers within our network. We initiated an investigation to understand the nature and scope of this event and determined that an unauthorized actor accessed certain files within our network between October 10, 2023 and November 18, 2023.

We, along with the support of third-party specialists, conducted a thorough and in-depth review of the files to identify individuals whose personal information was potentially impacted. This extensive process was completed on August 28, 2024. We thereafter worked to notify potentially impacted individuals. You are receiving this notification because we determined that certain information related to you resided in the accessible data.

What Information Was Involved. The investigation determined that the following information of yours resided in the accessible data: name [Extra2].

What We Are Doing. The confidentiality, privacy, and security of information in our care are among our highest priorities. Upon becoming aware of the event, we investigated and responded to it, assessed the security of our network, and notified potentially affected individuals. We regret any inconvenience or concern this event may cause. As part of our ongoing commitment to the privacy and security of information in our care, we regularly review and enhance our existing policies and procedures related to data privacy to reduce the likelihood of a similar event reoccurring in the future. We are notifying relevant regulatory authorities, as required. As an added precaution, we are also offering credit and identity monitoring services through Experian for ## months, at no cost to you.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and credit reports for suspicious activity and to report any suspicious activity promptly to your bank, credit card company, or other applicable institution. Additional information and resources are included in the enclosed *Steps You Can Take To Protect Your Personal Information*. You may also enroll in the complimentary credit and identity monitoring services available to you. Enrollment instructions are attached to this letter. Please note, due to privacy restrictions, we cannot enroll you in these services.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit

www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial, as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Additional Information

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General. Please note that in order to file a report with law enforcement for identity theft, consumers will likely need to provide some proof that they have been a victim. Instances of known or suspected identity theft should also be reported to law enforcement and the relevant state Attorney General. This notice has not been delayed by law enforcement.
