Delta County Memorial Hospital District ("Delta") values your privacy, which is why we are contacting you about an incident that may have involved some of your personal information. While we have no reason to believe this information has been misused, we want to make you aware of the incident and provide information about what you can do to protect yourself, should you feel it is appropriate to do so.

**What Happened?** On May 30, 2024, Delta became aware of suspicious activity on its computer network. Upon detecting the suspicious activity, Delta notified law enforcement and immediately began an investigation with the help of leading cybersecurity experts. The investigation determined that an unknown, unauthorized third party gained access to Delta's network between May 27, 2024 and May 30, 2024 and may have acquired certain files from Delta's systems.

What Information Was Involved? On November 1, 2024, we determined that the files involved in the incident may contain your name, date of birth, phone number, address, financial account information, medical information, health insurance information, Social Security number, and/or driver's license number.

What We Are Doing. Although we are not aware of any instances of fraud or identity theft involving your information, we are offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on prompt identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter. In addition to the actions described above, we are taking steps to reduce the risk of this type of incident occurring in the future, including further enhancing our security measures.

What You Can Do. While we have no evidence that your personal information has been misused, we encourage you to take advantage of the complimentary credit monitoring included in this letter. **Fraud Alerts:** By law, you have the right to place a fraud alert on your credit report if you believe you have been, or are about to become, a victim of fraud or related crime. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. <u>Credit and Security Freezes:</u> By law, you have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
