

# **EXHIBIT 1**

By providing this notice, Behavioral Health Resources (“BHR”) does not waive any rights or defenses regarding the applicability of Maine law, the applicability of the Maine data event notification statute, or personal jurisdiction.

### **Nature of the Data Event**

On or about November 20, 2024, BHR became aware of suspicious activity in its computer environment. BHR promptly engaged third-party cybersecurity experts to investigate the nature and scope of the event. The investigation determined that on or before November 20, 2024, an unauthorized actor gained access to certain systems and that certain information contained in those systems was accessible.

The investigation did not confirm that any information was actually viewed or taken during the event. Nonetheless, BHR conducted a thorough and comprehensive review to determine what information was accessible and to whom such information relates. BHR recently completed this process, and then moved as quickly as possible to provide notice.

The personal information related to Maine residents that could have been subject to unauthorized access includes name, Social Security Number, and driver's license number/government-issued ID.

### **Notice to Maine Residents**

To ensure compliance with potentially applicable laws and regulations, based on then-known information, while BHR’s review was ongoing, on January 17, 2025, BHR posted notice on its website, provided notice to the media in Washington State, and notified the U.S. Department of Health and Human Services (“HHS”).

On or about April 17, 2025, BHR continued notifying individuals by mailing written notice to individuals for whom it has complete address information, including approximately four (4) Maine residents. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon becoming aware of the activity, BHR moved quickly to investigate and respond to the event, assess the security of BHR systems, and identify potentially affected individuals. Further, BHR notified federal law enforcement and is working to implement additional safeguards and training to its employees.

Additionally, BHR is providing impacted individuals with guidance on how to better protect against identity theft and fraud, including advising individuals to report any suspected incidents of identity theft or fraud to their credit card company, bank, or other applicable institution. BHR is providing individuals with information on how to place a fraud alert and security freeze on one’s credit file, information on protecting against tax fraud, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant

for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

BHR is providing written notice of this event to relevant state regulators, as required, and to the three major credit reporting agencies, Equifax, Experian, and TransUnion. BHR also submitted supplemental notice to HHS.

Behavioral Health Resources (“BHR”) writes to inform you of an event that may involve some of your information. Although we have received no indication of identity theft or fraud as a result of the event, this notice provides information about the event, our response, and resources available to help you help protect your information from possible misuse, should you feel it is necessary to do so.

**What Happened?** On or about November 20, 2024, BHR became aware of suspicious activity in our computer environment. We promptly engaged third-party cybersecurity experts to investigate the nature and scope of the event. The investigation determined that on or before November 20, 2024, an unauthorized actor gained access to certain systems and that certain information contained in those systems was accessible.

The investigation did not confirm that any information was actually viewed or taken during the event. Nonetheless, we conducted a thorough and comprehensive review to determine what information was accessible and to whom such information relates. We recently completed this process, and then moved as quickly as possible to provide notice.

**What Information Was Involved?** There is no evidence that your information was actually viewed or taken as a result of the event. Nonetheless, our investigation determined that your name, and <<Breached Elements>><<Variable Data 1>> were accessible.

**What We Are Doing?** We take this event and information security very seriously. Upon becoming aware of the event, we moved quickly to investigate and respond to the event, assess the security of our computer environment, and notify potentially affected individuals. We are notifying potentially affected individuals, including you, so that you may take further steps to best protect your information, should you feel it is necessary to do so. We regret any inconvenience or concern this event may cause. As an added precaution, we are offering credit monitoring and identity restoration services through Equifax for <<CM Duration>>, at no cost to you. Please note that although we are covering the cost of these services, due to privacy restrictions, you will need to complete the activation process yourself using the enrollment instructions enclosed with this letter.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your <<Variable Data 2>> for suspicious activity and to detect errors. Any suspicious activity should be promptly reported to your bank, credit card company, or other applicable institution. Additional information and resources are included in the enclosed *Steps You Can Take to Protect Personal Information*.

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
