Alpha Baking Co., Inc. values the privacy of your personal information. We are writing to tell you about a recent incident that involved some of your personal information. We have no evidence that your personal information has been misused as a result of this incident. That said, we are providing you with information about what happened and what you can do.

What Happened? On January 23, 2025, we identified unusual activity on our computer network. We immediately took steps to investigate. A forensic investigation conducted by external experts determined that an unauthorized third party obtained certain files stored on our network. We retained a team to review the contents of the documents we believe may have been taken for sensitive personal information. That review was completed, and the results were provided to us, on May 2, 2025.

What Information Was Involved? After our review of the files that we believe may have been taken, at least one document included your << b2b text 2 (name, data elements)>>.

What We Are Doing. We have taken steps to reduce the risk of a future security incident, including further enhancing our existing security measures and increasing monitoring and hardening of our systems. Although we are not aware of any instances of fraud or identity theft stemming from this incident, out of an abundance of caution we are also offering a complimentary one-year membership of Credit Monitoring, Fraud Consultation, and Identity Theft Restoration services. This product helps detect possible misuse of your personal information and provides you with identity monitoring services. Instructions on how to activate your complimentary one-year membership are enclosed.

What You Can Do. We encourage you to sign up for the complimentary identity monitoring offer. You can also find more information on steps to help protect yourself against possible identity theft or fraud in the enclosed *Additional Important Information* page.

Fraud Alerts: You may want to consider placing a fraud alert on your credit report. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company. Since the instructions for how to establish a credit freeze differ from state to state, please contact the three major credit reporting companies as specified below to find out more information:
