CEI Vision Partners, LLC ("CVP") operates a network of eye care practices, including Columbus Ophthalmology Associates. CVP values and respects the confidentiality of your personal information, which is why we are writing to advise you of a recent incident that may have involved some of your information and to provide you with guidance on what you can do to protect yourself, should you feel it is appropriate to do so.

**What Happened?** On May 26, 2024, we discovered that an unknown, unauthorized third party gained temporary access to CVP's computer network. Upon discovery, we promptly secured the network from further unauthorized access and began an internal investigation. We also engaged a forensic security firm to further investigate and confirm the security of our computer systems. The forensic investigation determined that the unauthorized party accessed certain CVP computer systems between May 24, 2024, and May 27, 2024. We have undertaken a thorough review of the relevant records that required considerable time to ensure accuracy and completeness. We have recently completed this review.

**What Information Was Involved?** Based on the findings of the investigation, we conducted a review of the files potentially accessed by the unauthorized party to determine if they contained any personal information. On June 10, 2025, we completed this review and determined that the files that were potentially accessed contained some personal information. The type of information varied for each individual but may have included your name and contact information, together with your date of birth, Social Security number, financial account information, limited clinical information, and/or health plan information.

**What We Are Doing.** In addition to the actions described above, we are taking steps to reduce the risk of this type of incident occurring in the future, including enhancing our technical security measures. We are also notifying you of the incident so that you are aware and take steps to protect yourself if you feel it is appropriate to do so. Finally, although we are not aware of any instances of fraud or identity theft involving your personal information, we are also offering a complimentary one-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. IdentityWorks Credit 3B is completely free to you, and enrolling in this program will not hurt your credit score. **For more information on identity theft prevention and IdentityWorks Credit 3B, including instructions on how to activate your complimentary one-year membership, please see the additional information provided in this letter.**

**What You Can Do.** While we do not believe that your personal information has been misused as a result of this incident, we encourage you to take advantage of the complimentary credit monitoring provided in this letter. **Fraud Alerts:** By law, you have the right to place a fraud alert on your credit report if you believe you have been, or are about to become, a victim of fraud or related crime. A fraud alert is free and will stay on your credit report for one (1) year. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. To place a fraud alert on your credit report, contact any of the three national credit reporting agencies using the contact information listed above. **Credit and Security Freezes:** By law, you have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
